SUBJECT: **NOTICE OF FAILURE OF BIDDING OF THE 6 MW CSP**

This Supplemental Bid Bulletin is issued on the basis of the following antecedent facts:

1. On January 10, 2021 and January 17, 2021, the BLCI CSP TPBAC published an Invitation to Bid for the Procurement of 6MW Baseload Power Supply thru Competitive Selection Process (CSP), via National and Local Newspapers, *The Philippine Daily Inquirer* and *The Bohol Chronicle*, respectively.
2. Within the set deadline, January 27, 2021 at 5:00PM, only one (1) Generation Company (GenCo) (i.e. Prospective Bidder) submitted a Letter of Intent (LOI) along with proof of payment of the prescribed Bidding Document Fee.
3. Considering that there is only **one prospective bidder**, on January 28, 2021, the BLCI TPBAC sent a request letter to DOE for an Earlier Bid Opening/Adjustment of Transaction Schedule, stating compliance with Section 5.1 of the Final Instructions to Bidders, wherein BLCI TPBAC reserves the right to modify the Transaction Schedule as it sees fit.
4. On February 24, 2021, the BLCI TPBAC received DOE's letter of approval in response to the **Request for an Earlier Bid Opening/Adjustment of Transaction Schedule**, thereby moving the Submission and Opening of Bid Proposals from April 23, 2021 to March 10, 2021.

In view of the Deadline for the Submission and Opening of Bid Proposals today, March 10, 2020, for the subject procurement, only one offer was received by the BLCI TPBAC.

As such, pursuant to Section 9.2.2 of DOE's Department Circular No. DC2018-02-0003, the bidding was hereby declared a failure.
